GROUND FLOOR PLAN

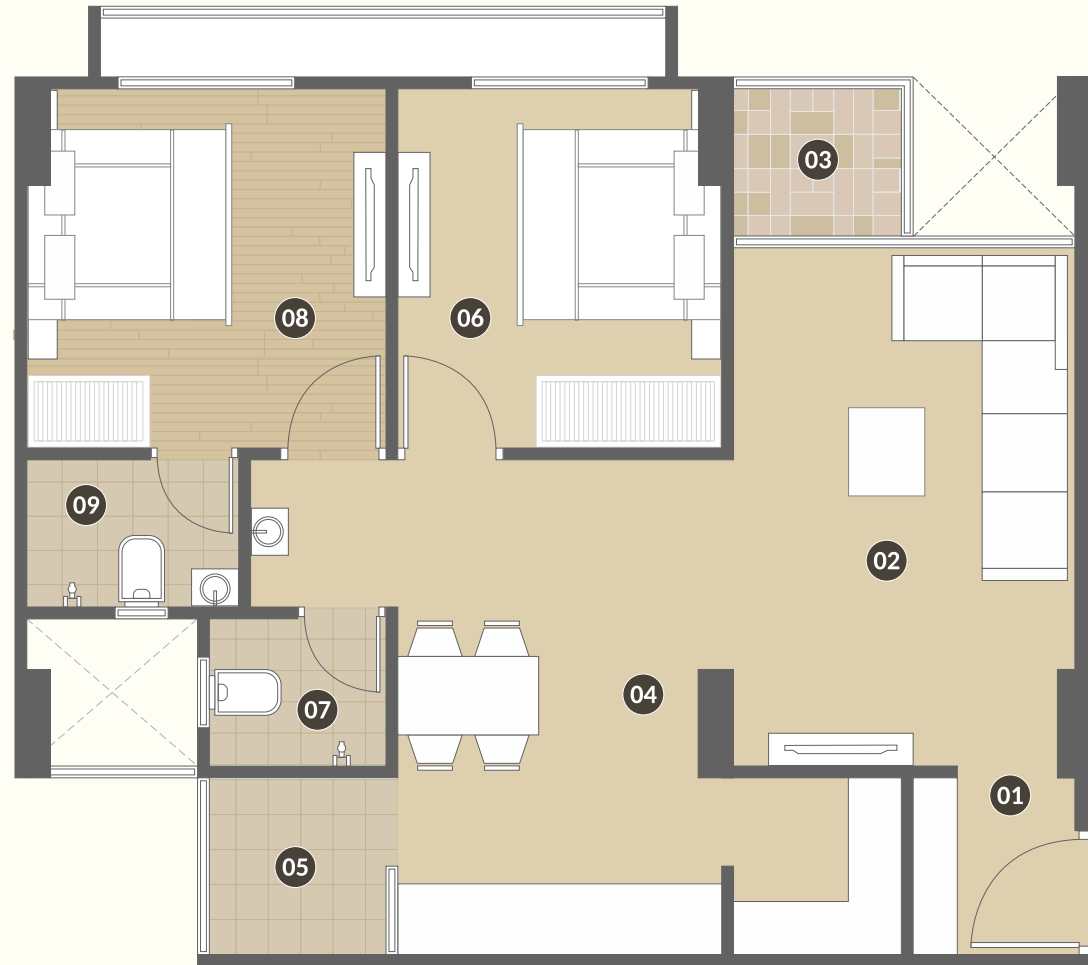
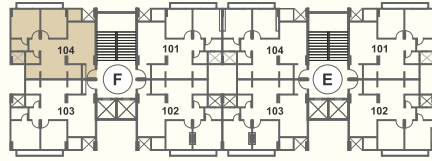

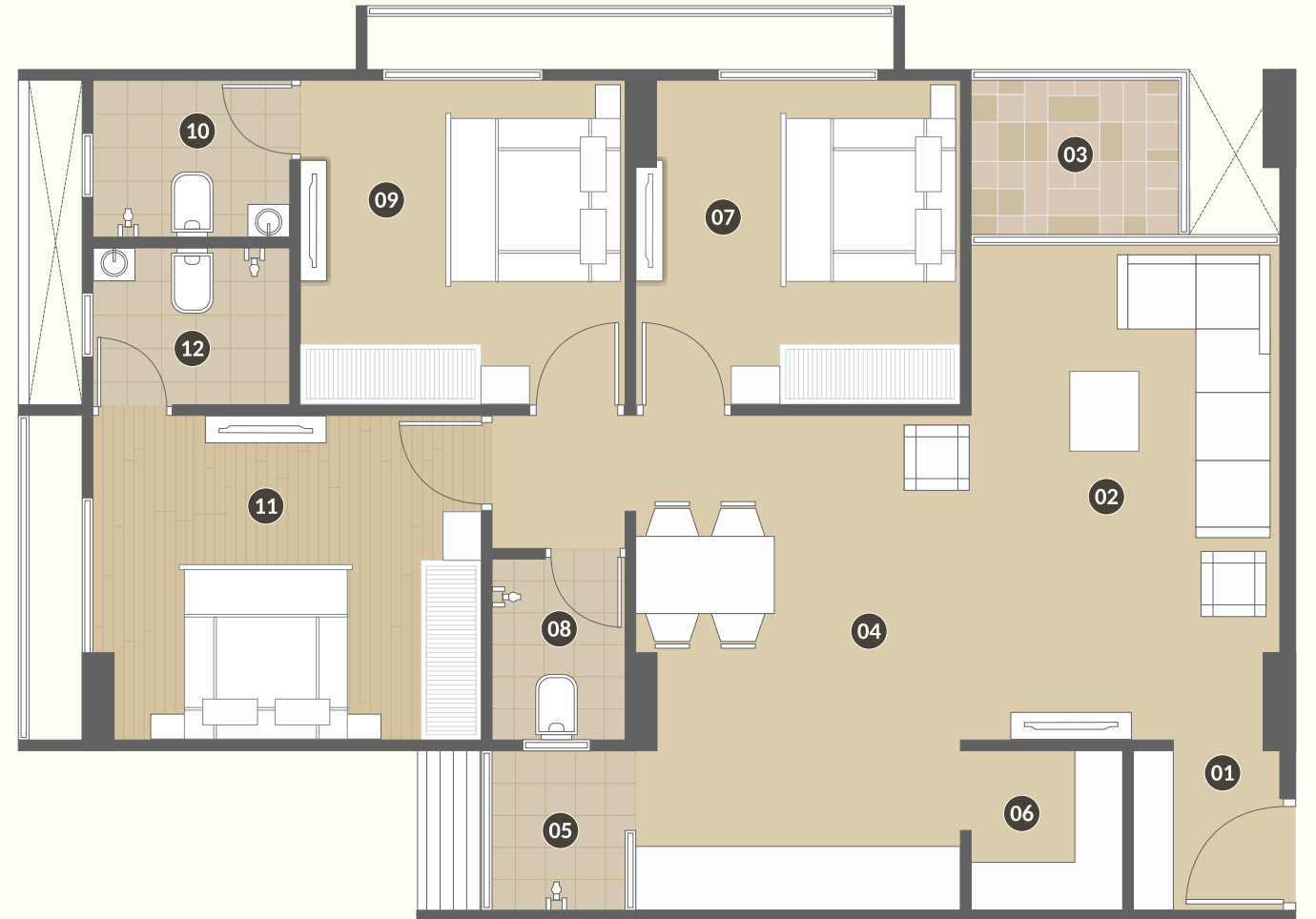
